#### Yes,

Description of change/improvement that would impact fair registration outcomes:

Initial Registration Fee Policy: In April 2022, Council approved a temporary registration fee policy change for new applicants eligible for registration from January 1, 2022, to August 31, 2022 of the 2021 – 2022 registration year. The change was driven by: the shift from an entry-to-practice examination that was held once a year to a national competency assessment held more than once a year; and, the financial barriers for potential applicants to register at different times in the registration year but still required to pay a full year fee. This policy change resulted in 25 of 36 eligible candidates registering by May 31, 2022. Historically these individuals would delay registration, practice under supervision and may never seek licensing to practice as a regulated health professional. Based on the uptake Council approved a permanent policy change to prorate initial registration fees on a quarterly basis. The change to the fee schedule in the By-laws took effect starting from the 2022 -2023 registration year. A formal policy was presented by the Registration Committee and approved by Council on September 23, 2022. This policy change demonstrates fair, equitable and reasonable practices for aspiring RDTs (Registered Dental Technologists) resulting in more accessibility to the profession for both applicants and Ontarians requiring dental technology services. ## Assessment of qualifications

#### Yes,

Description of change/improvement that would impact fair registration outcomes:

In response to the Ministry of Health consultations on Bill 106 the CDTO reported that it did not offer a Prior Learning Assessment Recognition (PLAR), a credentialing alternative to formal education. An environmental scan conducted with the dental technology regulators across Canada and other health professions in Ontario showed that limiting credentialing pathways to formal education only is a significant barrier for many, including those who are internationally educated, to becoming a regulated health professional. In October 2022 the Canadian Alliance of Dental Technology Regulators (CADTR) agreed to explore developing a national PLAR and in December 2022 approved drafting a funding proposal to submit to the Government of Canada. In order for the CDTO to recognize PLAR as an equivalent to formal education, changes to the Registration Regulation are necessary. CDTO has plans to submit amendments to the Registration Regulation to recognize PLAR as a credentialing pathway at the same time as the Emergency Class amendments.

Description of change/improvement that would impact fair registration outcomes:

In 2022, the CDTO responded to the MOH Bill 106 consultation for timelines of registration, decisions and responses. Our analysis shows that the CDTO currently complies with the timelines specified by O.Reg. 508/22, under the Regulated Health Professions Act, 1991, and Schedule 6 of the Pandemic and Emergency Preparedness Act, 2022, which comes into effect on January 1, 2023, which are: • within 15 days of receiving an application for registration, applicants receive written acknowledgement informing them that either all required items have been received, or additional item(s) are required to complete their application, and • within 15 days of receiving additional item(s) request, the applicant receives written acknowledgement informing them that either all required items have been received, or additional item(s) are required to complete their application. • within 30 days of receiving a complete application, the Registrar reaches a decision to register the applicant or refer the application to the Registration Committee (s.15(1) of the Code).

## Registration and assessment fees

#### Yes,

Description of change/improvement that would impact fair registration outcomes:

In April 2022, Council approved a temporary registration fee policy change for new applicants eligible for registration from January 1, 2022, to August 31, 2022 of the 2021 -2022 registration year. The change was driven by: the shift from an entry-to-practice examination that was held once a year to a national competency assessment held more than once a year; and, the financial barriers for potential applicants to register at different times in the registration year but still required to pay a full year fee. This policy change resulted in 25 of 36 eligible candidates registering by May 31, 2022. Historically these individuals would delay registration, practice under supervision and may never seek licensing to practice as a regulated health professional. Council considered this uptake along with the longer-term financial implications before approving a permanent policy change to prorate initial registration fees on a quarterly basis. The change to the fee schedule in the By-laws took effect starting from the 2022 - 2023 registration year. A formal policy was presented by the Registration Committee and approved by Council on September 23, 2022. This policy change demonstrates fair, equitable and reasonable practices for aspiring RDTs (Registered Dental Technologists) resulting in more accessibility to the profession for both applicants and Ontarians requiring dental technology services. When setting the registration and assessment fees the CDTO engages in a zero-based budgeting process, capturing the known and anticipated expenditures for the upcoming year. The types and level of expenditures are based on economic trends (inflation/CPI and interest rates), legislative directives, registrant numbers, operational efficiencies, and strategic initiatives that are now operational. To gain financial efficiencies, we work collaboratively with provincial and national system partners and seek external funding opportunities such as the Foreign Credential Recognition program and Canada Summer Jobs program.

Description of change/improvement that would impact fair registration outcomes:

A Memorandum of Understanding (MOU) between CADTR and CDTO which came into effect on January 1, 2021, sets out the credentialing and competency assessment services for applicants and defined performance standards and benchmarks. During the year: • CADTR CAS provided regular reports and updates on the number of applicants, credentialing outcomes and competency assessment pass/fail rates that were presented to the Board. • CADTR appointed a Competency Assessment Committee to review the existing Performance Based Assessment (PBA) stations to ensure testing of competencies is at the entryto-practice level identified in the Master Blueprint and oversee the development of new stations. • The PBA marking guides were also reviewed and training was provided to lead markers. • New Knowledge Based Assessment (KBA) items were developed and forms reviewed which allows for multiple administrations each year. • CDTO explored developing a national PLAR as a new pathway for credentialing and in December 2022 approved drafting a funding proposal to submit to the Government of Canada. CDTO is satisfied that CADTR is performing the credential and assessment services in a manner that complies with TOIF principles and applicable laws in Ontario. It is important to note that the MOU in no way affects the accountability of CDTO regarding its registration decisions.

Description of Change/Improvement that would impact Fair Registration Outcomes:

In early 2022, the CDTO revised its online portal to accept applications from individuals who successfully completed the national credentialing and competency assessments. We also moved to a virtually proctored Jurisprudence & Ethics exam which provides greater access to candidates in remote communities and is more cost effective.

Anti-racism and inclusion-based policies and practices

#### Yes,

Description of Change/Improvement that would impact Fair Registration Outcomes:

Anti-Racism and Equity, Diversity and Inclusion (EDI) continue to be a priority for the CDTO: In 2022, our work focused on: Education and training to provide foundational knowledge on EDI and its importance in delivering the CDTO's mandate. • Unconscious Bias (September 2022) -Learning about bias from both personal and organizational perspectives. As a health profession regulator, to move from symbolic or cosmetic change to systemic change, we recognize that unconscious bias remains a significant challenge in the registration policies and practices and that these hidden barriers hinder fair decision-making. • Equity, Diversity, and Inclusion (September 2022) - understanding EDI and why it is important, how to connect EDI to strategic priorities and develop a systems approach (organization vs. individuals), led by a consultant who assists non-profit organizations in maximizing and leveraging the benefits of their workforce diversity. • Truth and Reconciliation (September 2022) - education and awareness on Indigenous communities, the meaning of reconciliation and calls to action, and improving CDTO's land acknowledgement, facilitated by a member of the First Nations. Developing the HPRO Anti-Racism in Health Regulation project deliverables, funded by CSMARI and Health Profession Regulators of Ontario (HPRO) in-kind contributions. CDTO is actively supporting the work of the HPRO as it develops supports for Colleges to advance their work in EDI within policies, guidelines, standards, etc. Specifically, the September 2021 report commissioned by HPRO from Dr. Javeed Sukhera recommended that regulators should critically appraise existing policies, including an inclusive approach to policy co-design with racialized and minoritized stakeholders. The HPRO Anti-Racism in Health Regulation project provides valuable information for CDTO to use in conducting these reviews, including engagement with stakeholders. Current HPRO project activities are designed to provide a set of guiding indicators and tools or an equity impact assessment that CDTO will use in future reporting periods to ensure we apply an EDI lens in reviewing, developing, and amending our practices, prioritized according to our particular needs. Specifically, we will identify priority areas for a more thorough review of strengths and gaps, for action planning and implementation of actions to close the gaps. CDTO also continues its work from 2021 in developing the following framework and tools to ensure that EDI is reflected in all aspects of dental technology practice: • Standards Framework: The standards framework utilizes principles of

EDI incorporated within ethical principles and professional standards. This framework will utilize EDI principles to inform and impact all activities of RDTs in practice. See pages 96-98 of the September 23, 2022 Board Package. • Policy Framework: The framework outlines policies and procedures that support CDTO's mission, vision, and values and ensures that in the process of policymaking and drafting, the applicable EDI toolkits (e.g., EDI lens and policy, Equity Impact Assessment) will be utilized. • CDTO's EDI Framework: The EDI framework includes principles, tools, a lens, and policy to ensure that EDI is reflected in all aspects of CDTO's activities and dental technology practice. It aims to address systemic barriers, fairness, and competing interests, and encourages the use of inclusive language.
