# **Your Professional Responsibilities**

### **Public Register Update**

The public register is an important tool for many stakeholders to verify an RDTs registration status with the College and current and previous place(s) of practice.

Members of the public, employers, insurance companies, dentists, denturists, dental labs, and other health professionals may want to confirm the RDTs registration status and place of practice for a variety of reasons:

- to make informed decisions about who will be providing dental technology services
- to curtail fraudulent billings and unauthorized practice
- to verify the registration status of every RDT that works in their place of practice and of individuals applying for RDT positions

The public register has many benefits for the RDT by increasing transparency,

promoting trust, and providing protection against misinformation about your registration status and where you practiced should a complaint be received.

It is your professional responsibility to make sure that the public register reflects accurate information about you within thirty (30) days of a change and not just at annual renewal. Changes may include your name, communications address, and place of practice. Don't forget to end date a place of practice if you are no longer there! If you are adding a new place of practice and cannot find it in the drop-down menu, please complete and e-mail this form and required documentation to info@cdto.ca.

It takes only a few minutes to login to the <u>online portal</u> and make the updates yourself.

### **RDT Stamp**

All RDTs who renewed under the General certificate class of registration on September 1, 2022, should have received their RDT Stamp through Canada Post by October 31, 2022. If you have not received your RDT Stamp please contact us immediately by e-mail at <a href="mailto:info@cdto.ca">info@cdto.ca</a> or by phone at 416 438-5003 ext 221.

The RDT Stamp is the property of the College and it is your responsibility to familiarize yourself with <u>the College's expectations</u> on its use and security. RDTs are reminded to destroy expired stamps immediately unless you are requested to return it to the College. CDTO Laboratory Supervision Standard.

## **Administrative Suspension**

Annual renewal of the certificate of registration and payment of fees is a professional responsibility of all RDTs as set out in the By-laws. The College is required to suspend Registrants who do not pay their fees after receiving a notice of intention to suspend, also known as administrative suspension.

Under administrative suspension, you cannot hold yourself out as qualified to

practice dental technology under <u>section 32 (1) (b) and 32 (3) of the Regulated Health Professions Act, 1991 (RHPA)</u> and are not permitted to use dental technologist, the restricted title Registered Dental Technologist, or the designation RDT.

The following certificates of registration were suspended on October 17, 2022, and the Public Register updated to reflect a registration status of administrative suspension.

## **Strategic Planning Consultation**

# What's New?

## **New Pathways to Registration**

In 2020 CDTO along with six other dental technology regulators across Canada engaged the <u>Canadian Alliance of Dental Technology Regulators</u> (<u>CADTR</u>) to develop and administer the credential evaluation and competency assessment services (CAS). All applicants, other than those applying under the <u>labour mobility route</u>, must apply with CADTR and successfully complete CAS before registering with CDTO.

RDTs play an important role as a system partner in supporting Ontario's health care system and the needs of patients. Being informed, sharing information, and supporting aspiring RDTs to become licensed will benefit you and the public today and in the future.
